The Products of Animal Origin (Third Country Imports) (Scotland) Amendment Regulations 2009

Made - - - - 3rd June 2009

Laid before the Scottish Parliament 4th June 2009

Coming into force - - 26th June 2009

The Scottish Ministers make the following Regulations in exercise of the powers conferred by section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972(a) and all other powers enabling them to do so.

These Regulations make provision for a purpose mentioned in section 2(2) of the said Act and it appears to the Scottish Ministers that it is expedient for the references to Community instruments set out in Schedule 1 to the Products of Animal Origin (Third Country Imports) (Scotland) Regulations 2007(b) to be construed as references to those instruments as amended from time to time.

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Products of Animal Origin (Third Country Imports) (Scotland) Amendment Regulations 2009 and come into force on 26th June 2009.
- (2) In these Regulations "the 2007 Regulations" means the Products of Animal Origin (Third Country Imports) (Scotland) Amendment Regulations 2007.

Amendment to the 2007 Regulations

- **2.**—(1) The 2007 Regulations are amended as follows.
- (2) In regulation 4 (exemption for authorised products and personal imports) for paragraphs (7) and (8) substitute—
 - "(7) Part 3, with the exception of regulation 25, and Parts 4 to 9 do not apply to products of animal origin specified in Article 2 of Commission Regulation (EC) No. 206/2009 on the introduction into the Community of personal consignments of products of animal origin and amending Regulation (EC) No. 136/2004(c)."
- (3) For Schedule 1 (import conditions) substitute the Schedule set out in the Schedule to these Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations replace Schedule 1 to the Products of Animal Origin (Third Country Imports) (Scotland) Regulations 2007 (S.S.I. 2007/1) ("the Principal Regulations").

They also revoke the Products of Animal Origin (Third Country Imports) (Scotland) Amendment (No. 2) Regulations 2006 (S.S.I. 2006/419).

New Schedule 1 (import conditions) to the Principal Regulations as inserted by these Regulations is a rolling consolidation of that Schedule, listing both the Community instruments in that Schedule when the Principal Regulations were made and relevant Community instruments adopted since then. The new Schedule provides updated references to the Community instruments that set out the requirements to be enforced under the Principal Regulations when the products of animal origin in question are imported or exported from or to third (non-EU) countries.

The references to Community instruments contained within the new Schedule are to be construed as references to the text of those instruments as amended from time to time. 'As amended' versions of the Community instruments can be found at any time on the Eur-Lex website (http://eur-lex.europa.eu/en/index.htm).
