Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) 2001 ("y prif Reoliadau"), sy'n darparu ar gyfer codi a chasglu ffioedd am gyffuriau a chyfarpar sy'n cael eu cyflenwi gan feddygon a fferyllwyr sy'n darparu gwasanaethau fferyllol a gweinyddol, a chan Fyrddau Iechyd Lleol ac Ymddiriedolaethau GIG i gleifion allanol.

These Regulations further amend the National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001 ("the principal Regulations") which provide for the making and recovery of charges for drugs and appliances supplied by doctors and chemists providing pharmaceutical and dispensing services, and by Local Health Boards and NHS Trusts to out-patients.

Mae rheoliad 2 o'r prif Reoliadau yn cael ei ddiwygio fel y bydd cyfeiriadau at "awdurdod iechyd" yn cael eu trin fel cyfeiriadau at "fwrdd iechyd lleol".

Regulation 2 of the principal Regulations is amended so that references to a "health authority" will be treated as references to a "local health board".

Mae'r diwygiadau a wneir gan reoliad 3 a'r Atodlen yn gostwng y ffi am eitemau ar bresgripsiwn a gyflenwir i gleifion allanol o £6.00 i £5.00. Gostyngir y ffi am hosanau elastig o £6.00 i £5.00 (o £12.00 i £10.00 fesul pâr) a'r ffi am deits o £12.00 i £10.00. Gostyngir y symiau a ragnodir i roi tystysgrifau rhagdalau o £31.40 i £26.16 am dystysgrif pedwar mis ac o £86.20 i £71.83 am dystysgrif deuddeg mis.

Amendments made by regulation 3 and the Schedule reduce the charge for items on prescription supplied to out-patients from £6.00 to £5.00. The charge for elastic stockings is reduced from £6.00 to £5.00 (from £12.00 to £10.00 per pair) and that for tights from £12.00 to £10.00. The sums prescribed for the grant of pre-payment certificates are reduced from £31.40 to £26.16 for a four month certificate and from £86.20 to £71.83 for a twelve month certificate.

Mae diwygiadau a wneir gan reoliad 4 yn darparu na fydd ffi yn daladwy gan bersonau o dan 25 oed am gyflenwi cyfarpar a chyffur penodol yn unol â rheoliad 5 o'r prif Reoliadau (cyflenwi cyffuriau a chyfarpar gan Fyrddau Iechyd Lleol ac Ymddiriedolaethau GIG).

Amendments made by regulation 4 provide that no charge will be payable by persons under the age of 25 years for the supply of certain appliances and drugs in accordance with regulation 5 of the principal Regulations (supply of drugs and appliances by Local Health Boards and NHS Trusts).

Mae Cynulliad Cenedlaethol Cymru, trwy arfer y pwerau a roddwyd iddo gan adrannau 77 a 126(4) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977(a) drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred upon it by sections 77 and 126(4) of the National Health Service Act 1977(a) hereby makes the following Regulations:

Enwi, cychwyn, dehongli a chymhwyso**Citation, commencement, interpretation and application**

1.-(1) Enw'r rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) (Diwygio) 2004 a deuant i rym ar 1 Hydref 2004.

1.-(1) These Regulations may be cited as the National Health Service (Charges for Drugs and Appliances) (Wales) (Amendment) Regulations 2004 and come into force on 1 October 2004.

(2) Yn y Rheoliadau hyn, ystyr "y prif Reoliadau" (*the principal Regulations*) yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) 2001(b).

(2) In these Regulations "the principal Regulations" (*the principal Regulations*) means the National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001(b).

(3) Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig.

(3) These Regulations apply to Wales only.

Diwygio rheoliad 2 o'r prif Reoliadau

2.-(1) Mae Rheoliad 2 o'r prif Reoliadau (dehongli) yn cael ei ddiwygio yn unol â darpariaethau canlynol y rheoliad hwn.

(2) Ym mharagraff (1) mewnosoder y diffiniad canlynol yn y lle priodol yn nhrefn yr wyddor-

"mae i "Bwrdd Iechyd Lleol" yr ystyr a roddir i "Local Health Board" gan adran 16BA o'r Ddeddf;".

(3) Ar ôl paragraff (1), mewnosoder y paragraff canlynol-

"(1A) Bydd y geiriau "Awdurdod Iechyd", ym mhob man lle maent yn digwydd, yn effeithiol fel pe rhoddwyd yn eu lle'r geiriau "Bwrdd Iechyd Lleol".".

Diwygio symiau a bennir yn y prif Reoliadau

3. Am bob swm a bennir yng ngholofn (3) o'r Atodlen i'r Rheoliadau hyn, lle mae'n ymddangos yn narpariaeth y prif Reoliadau a bennir mewn perthynas ag ef yng ngholofn (1) (y dangosir y pwnc amdano yng ngholofn (2)), rhodder y swm a bennir mewn perthynas ag ef yng ngholofn (4) yn ei le.

Diwygio rheoliad 8 o'r prif Reoliadau

4. Yn rheoliad 8(2)(b) yn lle "is-baragraff (b)" rhodder "is-baragraff (a)".

Amendment of regulation 2 of the principal Regulations

2.-(1) Regulation 2 of the principal Regulations (interpretation) is amended in accordance with the following provisions of this regulation.

(2) In paragraph (1) insert the following definition in the appropriate place in the alphabetical order-

"Local Health Board" ("*Bwrdd Iechyd Lleol*") has the meaning assigned to it by section 16BA of the Act;".

(3) After paragraph (1), insert the following paragraph-

"(1A) The words "Health Authority" shall, in each place they occur, have effect as if there were substituted the words "Local Health Board".".

Amendment of amounts specified in the principal Regulations

3. For each amount specified in the column (3) of the Schedule to these Regulations, where it appears in the provision of the principal Regulations specified in relation to it in column (1) (the subject matter of which is indicated in column (2)), substitute the amount specified in relation to it in column (4).

Amendment of regulation 8 of the principal Regulations

4. In regulation 8(2)(b), for "sub-paragraph (b)" substitute "sub-paragraph (a)".
