Mae'r Gorchymyn hwn yn dwyn i rym ar 1 Awst 2004 ac 1 Medi 2004 y darpariaethau hynny yn Neddf Addysg 2002 a bennir yn Rhannau 1 a 2 o'r Atodlen i'r Gorchymyn hwn.

This Order brings into force on 1st August 2004 and 1st September 2004 those provisions of the Education Act 2002 specified in Parts 1 and 2 of the Schedule to this Order.

Mae'r cyfeiriadau isod at adrannau ac Atodlenni (heb fanylion pellach) yn gyfeiriadau at adrannau o Ddeddf Addysg 2002 ac Atodlenni iddi.

References below to sections and Schedules (without more) are references to sections of and Schedules to the Education Act 2002.

Yn achos darpariaethau sy'n cael eu dwyn i rym gan y Gorchymyn hwn ac sy'n diwygio deddfwriaeth sy'n bodoli eisoes, mae'r cyfeiriadau at yr Ysgrifennydd Gwladol yn y darpariaethau hynny i'w darllen, mewn perthynas â Chymru, fel cyfeiriadau at Gynulliad Cenedlaethol Cymru - gweler adran 211.

In the case of provisions brought into force by this Order which amend existing legislation, references to the Secretary of State in those provisions are to be read, in relation to Wales, as references to the National Assembly for Wales - see section 211.

Mae effaith y darpariaethau a bennir yn Rhan 1 o'r Atodlen fel a ganlyn -

The effect of the provisions specified in Part 1 of the Schedule is as follows -

Mae adran 72 ac Atodlen 9 yn diwygio Deddf Dysgu a Medrau 2000 er mwyn galluogi Cyngor Cenedlaethol Cymru dros Addysg a Hyfforddiant i gynnig sefydlu, addasu neu gau dosbarthiadau chwech. Mae ei gynigion i'w cyflwyno i Gynulliad Cenedlaethol Cymru ("y Cynulliad Cenedlaethol"). Nodir y gweithdrefnau mewn rheoliadau.

Section 72 and Schedule 9 amend the Learning and Skills Act 2000 so as to enable the National Council for Education and Training for Wales to propose the establishment, alteration or closure of sixth forms. Its proposals are to be submitted to the National Assembly for Wales ("the National Assembly"). Regulations will set out the procedures.

The effect of the provisions specified in Part 2 of the Schedule is as follows -

Mae adrannau 21, 22, 30 a 32 yn ailddeddfu darpariaethau penodol yn Neddf Safonau a Fframwaith Ysgolion 1998 ("Deddf 1998") ynglŷn

Sections 21, 22, 30 and 32 re-enact certain provisions of the School Standards and Framework Act 1998 ("the 1998 Act") in relation to the

â llywodraethu ysgolion a gynhelir.

Mae adran 21 yn darparu mai corff llywodraethu ysgol sy'n gyfrifol am ei rhedeg. Mae'n galluogi'r Cynulliad Cenedlaethol i wneud rheoliadau sy'n nodi rolau a chyfrifoldebau cyrff llywodraethu, penaeithiaid ac AALI.

Mae adran 22 yn darparu bod rhaid i AALI ddarparu gwybodaeth a hyfforddiant yn rhad ac am ddim i lywodraethwyr.

O dan adran 30 rhaid i gorff llywodraethu baratoi adroddiad blynyddol. Bydd y rheoliadau a wneir gan y Cynulliad Cenedlaethol yn nodi'r gofynion ynglŷn â chynnwys adroddiadau blynyddol a'u dosbarthu. Rhaid i gyrff llywodraethu ddarparu adroddiadau o'r fath i'r AALI yn unol â'i ofynion, a rhaid i bennaethiaid ddarparu adroddiadau o'r fath i gyrff llywodraethu neu AALI yn unol â'u gofynion hwythau.

Mae adran 32 yn nodi, o ran gwahanol categorïau o ysgol, y corff sy'n gyfrifol am benderfynu dyddiadau tymhorau ysgol, gwyliau ysgol ac amserau sesiynau ysgol. Caiff y Cynulliad Cenedlaethol wneud rheoliadau ynglŷn â chynigion i newid amserau sesiynau ysgol.

Mae adran 39 yn cynnwys diffiniadau.

Mae adran 155 ac Atodlen 14 yn diwygio Atodlen 26 i Ddeddf 1998 sy'n gwneud darpariaeth ynglŷn ag arolygu addysg feithrin. Bydd y diwygiadau hyn yn caniatáu i arolygiadau gael eu gwneud gan aelodau o'r arolygiaeth yn ogystal ag arolygwyr meithrinfydd cofrestredig, ac yn caniatáu i Brif Arolygydd Ei Mawrhydi dros Addysg a Hyfforddiant yng Nghymru gofrestru'r personau hynny y mae hi'n barnu eu bod yn briodol a chymryd i ystyriaeth yr angen am arolygwyr yng Nghymru. O'r blaen cofrestrodd hi unrhyw berson a fodlonodd y meini prawf statudol. Mae Atodlen 14 yn cynnwys diwygiadau hefyd a fydd yn golygu y bydd apelau yn erbyn penderfyniadau ar gofrestru yn cael eu gwneud yn Lloegr i'r tribiwnlys a sefydlwyd o dan adran 9 o Ddeddf Amddiffyn Plant 1999. Bydd apelau yng Nghymru yn parhau i gael eu gwneud i Dribiwnlys yr Arolygydd Meithrinfydd Cofrestredig, ond mae rhai diwygiadau sy'n ganlyniad i'r newidiadau yn Lloegr.

Mae adran 176 yn gosod dyletswydd ar AALI a chyrrff llywodraethu i roi sylw i ganllawiau'r Cynulliad Cenedlaethol ynglŷn ag ymgynghori â disgyblion ynghylch gwneud penderfyniadau sy'n effeithio arnynt.

government of maintained schools.

Section 21 provides that the governing body of a school is responsible for its conduct. It enables the National Assembly to make regulations setting out the roles and responsibilities of governing bodies, head teachers and LEAs.

Section 22 provides that an LEA must provide governors with information and training, free of charge.

Under section 30 a governing body must prepare an annual report. Regulations made by the National Assembly will set out requirements in relation to the content of annual reports and their distribution. Governing bodies must provide such reports to the LEA as it requires, and head teachers must provide such reports to governing bodies or LEAs as they require.

Section 32 sets out, in relation to different categories of school, the body which is responsible for determining the dates of school terms, school holidays and school session times. The National Assembly may make regulations as to proposals to change the times of school sessions.

Section 39 contains definitions.

Section 155 and Schedule 14 amend Schedule 26 to the 1998 Act which makes provision in relation to inspection of nursery education. These amendments will allow inspections to be carried out by members of the inspectorate as well as registered nursery inspectors, and allow Her Majesty's Chief Inspector of Education and Training in Wales to register those persons she considers appropriate and to take into account the need for inspectors in Wales. Previously she registered any person who satisfied the statutory criteria. Schedule 14 also contains amendments which will mean that appeals against decisions on registration will be made in England to the tribunal established under section 9 of the Protection of Children Act 1999. Appeals in Wales will continue to be made to the Registered Nursery Inspector's Tribunal, but there are some amendments which are consequential on the changes in England.

Section 176 imposes a duty on LEAs and governing bodies to have regard to National Assembly guidance about consultation with pupils in connection with taking decisions affecting them.
