EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyr) (Mân Dreuliau) 1997 ("Rheoliadau 1997") at ddibenion "cwestiwn perthnasol". Mae hwn yn gwestiwn o dan Reoliadau 1997 o ran a oes gan rieni disgybl a gynorthwyr hawl i grant gwisg ysgol o dan Ran II, neu grant teithio o dan Ran III, o Reoliadau 1997 sy'n codi ynglŷn â blwyddyn ysgol sy'n dechrau ar neu ar ôl 1 Medi 2005 ac nas penderfynwyd ar y dyddiad y daw'r Rheoliadau hyn i rym.

These Regulations amend the Education (Assisted Places) (Incidental Expenses) Regulations 1997 ("the 1997 Regulations") for the purposes of a "relevant question". This is a question under the 1997 Regulations as to whether the parents of an assisted pupil are entitled to a uniform grant under Part II, or a travel grant under Part III, of the 1997 Regulations which arises in respect of a school year beginning on or after 1st September 2005 and has not been determined at the date on which these Regulations come into force.

Mae Rheoliadau 1997 yn darparu ar gyfer talu grantiau o ran mân dreuliau, ac ar gyfer peidio â chasglu mân dreuliau, mewn perthynas â disgyblion sy'n gymwys i barhau i ddal lleoedd a gynorthwyr mewn ysgolion annibynnol yn rhinwedd adran 2 o Ddeddf Addysg (Ysgolion) 1997, er bod y cynllun lleoedd a gynorthwyr wedi'i ddiddymu gan adran 1 o'r Ddeddf honno.

The 1997 Regulations provide for the payment of grants as regards incidental expenses, and for the remission of incidental expenses, in respect of pupils eligible to continue to hold assisted places at independent schools by virtue of section 2 of the Education (Schools) Act 1997, notwithstanding the abolition of the assisted places scheme by section 1 of that Act.

Mae'r Rheoliadau hyn yn llacio'r prawf moddion ariannol ar gyfer grantiau gwisg ysgol a grantiau teithio (a nodir yn rheoliad 2 a 4 o Reoliadau 1997 yn eu trefn) ac yn cynyddu swm y grant sy'n daladwy.

These Regulations relax the uniform and travel grants means tests (set out in regulation 2 and 4 of the 1997 Regulations respectively) and increase the amount of grant payable.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adran 3(3), (4), (5) a (9) o Ddeddf Addysg (Ysgolion) 1997(1) ac sydd bellach yn arferadwy gan Gynulliad Cenedlaethol Cymru(2):

The National Assembly for Wales makes the following Regulations under the powers conferred on the Secretary of State by section 3(3), (4), (5) and (9) of the Education (Schools) Act 1997(1) and now exercisable by the National Assembly for Wales(2):

Enwi, cychwyn a chymhwyso**Title, commencement and application**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Lleoedd a Gynorthwyir) (Mân Dreuliau) (Diwygio) (Cymru) 2005 a deuant i rym ar 14 Hydref 2005.

1.-(1) The title of these Regulations is the Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2005 and they come into force on 14 October 2005.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru ynghylch cwestiwn perthnasol.

(2) These Regulations apply in relation to Wales in respect of a relevant question.

(3) Ym mharagraff (2) uchod, ystyr "cwestiwn perthnasol" yw'r ystyr a roddir i "relevant question" o dan Rheoliadau Addysg (Lleoedd a Gynorthwyir) (Mân Dreuliau) 1997 o ran a oes gan rieni disgybl a gynorthwyir hawl i grant gwisg ysgol o dan Ran II, neu grant teithio o dan Ran III, o'r Rheoliadau hynny-

(3) In paragraph (2) above, a "relevant question" means a question under the Education (Assisted Places) (Incidental Expenses) Regulations 1997 as to whether the parents of an assisted pupil are entitled to a uniform grant under Part II, or a travel grant under Part III, of those Regulations which-

(a) sy'n codi ynglŷn â blwyddyn ysgol sy'n dechrau ar neu ar ôl 1 Medi 2005; a

(a) arises in respect of a school year beginning on or after 1 September 2005; and

(b) nas penderfynwyd ar y dyddiad y daw'r Rheoliadau hyn i rym.

(b) has not been determined at the date on which these Regulations come into force.

2.-(1) Diwygir Rheoliadau Addysg (Lleoedd a Gynorthwyr) (Mân Dreuliau) 1997(1) fel a ganlyn.

(2) Yn rheoliad 2(2), yn lle "£12,846" rhodder "£13,116".

(3) Yn lle rheoliad 2(3)(a) a (b) rhodder-

"(a) £81 where the relevant income does not exceed £12,182; and

(b) £42 where that income exceeds £12,182 but does not exceed £13,116."

(4) Yn rheoliad 4-

(a) ym mharagraff (3), yn lle "£11,948" rhodder "£12,195"; a

(b) ym mharagraff (4)-

(i) yn lle "£11,948" rhodder "£12,195", a

(ii) yn lle "£11,769" rhodder "£12,016".

Amendment of the Education (Assisted Places) (Incidental Expenses) Regulations 1997

2.-(1) The Education (Assisted Places) (Incidental Expenses) Regulations 1997(1) are amended as follows.

(2) In regulation 2(2), for "£12,846" there is substituted "£13,116".

(3) For regulation 2(3)(a) and (b) there is substituted-

"(a) £81 where the relevant income does not exceed £12,182; and

(b) £42 where that income exceeds £12,182 but does not exceed £13,116."

(4) In regulation 4-

(a) in paragraph (3), for "£11,948" there is substituted "£12,195"; and

(b) in paragraph (4)-

(i) for "£11,948" there is substituted "£12,195", and

(ii) for "£11,769" there is substituted "£12,016".
