**The Calderdale and Huddersfield National Health Service
Trust (Establishment) Order 2001**

Made - - - - 1st March 2001

Coming into force 12th March 2001

The Secretary of State for Health, in exercise of the powers conferred on him by section 5(1) of, and paragraphs 1, 3, 4 and 5 of Schedule 2 to, the National Health Service and Community Care Act 1990(a) and of all other powers enabling him in that behalf, having completed the consultation prescribed by section 5(2) of that Act(b), hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Calderdale and Huddersfield National Health Service Trust (Establishment) Order 2001 and shall come into force on 12th March 2001.

(2) In this Order, unless the context otherwise requires—

“the Act” means the National Health Service and Community Care Act 1990;

“community health services” means any services which the Secretary of State may provide under section 3(1)(d) or (e) of, or Schedule 1 to, the National Health Service Act 1977 and any service which he has a duty to provide under section 5(1) or (1A) of that Act(c);

“establishment date” means 12th March 2001;

“operational date” has the meaning assigned to it in paragraph 3(1)(e) of Schedule 2 to the Act;

“the trust” means the Calderdale and Huddersfield National Health Service Trust established by article 2 of this Order.

Establishment and name of the trust

2. There is hereby established an NHS trust which shall be called the Calderdale and Huddersfield National Health Service Trust.

Nature and functions of the trust

3.—(1) The trust is established for the purposes specified in section 5(1) of the Act.

(2) The trust’s functions shall be to provide goods and services, namely hospital

accommodation and services and community health services, for the purposes of the health service at or from:

- (i) The Calderdale Royal Hospital, Salterhebble, Halifax HX3 0PW;
- (ii) Holme Valley Memorial Hospital, Huddersfield Road, Holmfirth HD3 3TS;
- (iii) Huddersfield Royal Infirmary, Acre Street, Lindley, Huddersfield HD3 3EA;
- (iv) Princess Royal Community Health Centre, Greenhead Road, Huddersfield HD1 4EW;
- (v) St Luke's Hospital, Blackmoorfoot Road, Crosland Moor, Huddersfield HD4 5RQ,

and at or from associated hospitals, establishments or facilities in the area of Calderdale and Huddersfield.

Directors of the trust

4. The trust shall have, in addition to the chairman, 5 executive directors and 5 non-executive directors.

Operational date and accounting date of the trust

5.—(1) The operational date of the trust shall be 1st April 2001.

(2) The accounting date of the trust shall be 31st March.

Limited functions before operational date

6. Between its establishment date and its operational date the trust shall have the functions—

- (a) of entering into NHS contracts;
- (b) of entering into other contracts including contracts of employment; and
- (c) of doing such other things as are reasonably necessary to enable it to begin to operate satisfactorily with effect from its operational date.

Assistance by Health Authorities before operational date

7.—(1) Calderdale and Kirklees Health Authority shall discharge the liabilities of the trust, incurred between the establishment date and the operational date, that are of a description specified in paragraph (2) of this article.

(2) The liabilities referred to in the preceding paragraph are—

- (a) liability for the remuneration and travelling or other allowances of the chairman and non-executive directors of the trust;
- (b) liability for the travelling or other allowances of the members of committees and sub-committees of the trust who are not also directors of the trust;
- (c) liability for the remuneration of persons employed by the trust; and
- (d) any other liability which may reasonably be incurred by the trust for the purpose of enabling it to begin to operate satisfactorily with effect from the operational date.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order establishes the Calderdale and Huddersfield National Health Service Trust, an NHS trust provided for in section 5 of the National Health Service and Community Care Act 1990.

It provides for the functions of the trust (article 3) and the number of executive and non-executive directors (article 4). It specifies the operational date (the date on which the trust assumes all its functions), the accounting date of the trust (article 5) and the trust's limited functions before the operational date (article 6). It also specifies the trust's liabilities which will be discharged by the Calderdale and Kirklees Health Authority if incurred between the establishment date and the operational date (article 7).

This Order should be read in conjunction with the Calderdale Healthcare and the Huddersfield Health Care National Health Service Trusts (Dissolution) Order 2001^(a).
