**The South Stoke Primary Care Trust (Establishment)
Amendment Order 2002**

Made - - - - - *26th March 2002*

Coming into force *1st April 2002*

The Secretary of State for Health, in exercise of the powers conferred on him by sections 16A(1), (2) and (3) and 126(3) and (4) of the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, following compliance with the consultation requirements contained in regulations made under section 16A(5) of the Act(b), hereby makes the following Order:

Citation and commencement and interpretation

1.—(1) This Order may be cited as the South Stoke Primary Care Trust (Establishment) Amendment Order 2002 and shall come into force on 1st April 2002.

(2) In this Order—

“the Principal Order” means the South Stoke Primary Care Trust (Establishment) Order(c);
and

“the trust” means the trust established by the Order.

Amendment of the Schedule to the Principal Order

2.—(1) The Schedule to the Order shall be amended in accordance with the following paragraphs.

(2) In the entry for the City of Stoke on Trent, there shall be inserted after “Great Fenton”, “Hartshill”; after “Meir Park”, “Shelton” and “Stoke West”.
