**The Central Derby Primary Care Trust (Establishment)  
Amendment Order 2002**

*Made - - - - 21st March 2002*

*Coming into force 1st April 2002*

The Secretary of State for Health, in exercise of the powers conferred on him by sections 16A(1), (2) and (3) and 126(3) and (4) of, and paragraphs 1 and 2 of Schedule 5A to, the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, following compliance with the consultation requirements contained in regulations made under section 16A(5) of the Act(b), hereby makes the following Order:

**Citation and commencement**

1.—(1) This Order may be cited as the Central Derby Primary Care Trust (Establishment) Amendment Order 2002 and shall come into force on 1st April 2002.

(2) In this Order “the Order” means the Central Derby Primary Care Trust Establishment Order 2000(c).

**Amendment of Schedule to the Order**

2. In the Schedule to the Order (Area of Trust) after “Sinfin” there shall be added “Blagreaves”.
