**The Leeds Community and Mental Health Services Teaching  
National Health Service Trust (Change of Name) Order 2002**

*Made* - - - - - *19th June 2002*

*Coming into force* *1st July 2002*

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) and (4) of the National Health Service Act 1977(a) and section 5(1) of the National Health Service and Community Care Act 1990(b) and of all other powers enabling him in that behalf, having completed the consultation prescribed under section 5(2) of that latter Act(c), hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Leeds Community and Mental Health Services Teaching National Health Service Trust (Change of Name) Order 2002 and shall come into force on 1st July 2002.

(2) In this Order—

“the Order” means the Leeds Community and Mental Health Services Teaching National Health Service Trust (Establishment) Order 1992(d);

“the trust” means the National Health Service trust established by the Order.

**Change of name of NHS trust and transitional provisions**

2.—(1) The trust shall be called the Leeds Mental Health Teaching National Health Service Trust instead of the Leeds Community and Mental Health Services Teaching National Health Service Trust, and accordingly in article 1 of the Order in the definition of “the trust”, and in article 2 of the Order, for “Leeds Community and Mental Health Services Teaching National Health Service Trust” there shall be substituted “Leeds Mental Health Teaching National Health Service Trust”.

(2) The change of name effected by paragraph (1) shall not—

(a) affect any right or obligation of any person; or

(b) be taken as invalidating any instrument (whether made before, on or after the day on which this Order comes into force) which refers to the trust by its previous name,

and all instruments and other documents which refer to the trust under its previous name shall be construed as referring to it under its new name.
