The Secretary of State for Health, in exercise of the powers conferred upon him by sections 16A(1) and (2) and 126(3) of the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, hereby makes the following Order:

Citation, commencement and application

1.—(1) This Order may be cited as the Primary Care Trusts (Establishment) Amendment Order 2004 and shall come into force on 10th March 2004.

(2) This Order applies to England.

Amendment of Primary Care Trust Establishment Orders
