The St Albans (Parish Electoral Arrangements and Electoral Changes) Order 2007

Made - - - - 8th February 2007

Coming into force in accordance with article 1(2) and 1(3)

St Albans City Council, under section $9(\mathbf{a})$ of the Local Government and Rating Act $1997(\mathbf{b})$ ("the 1997 Act"), have made to the Electoral Commission(\mathbf{c}) proposals dated January 2007 for electoral arrangements in the parishes of Harpenden, Redbourn, St Michael and Wheathampstead(\mathbf{d}) in the city(\mathbf{e}) of St Albans and for electoral changes to two wards of the city of St Albans and two electoral divisions of the county of Hertfordshire:

The Electoral Commission have decided to give effect to those proposals and, in relation to the changes made on 1st April 2003 affecting the parishes of Harpenden and Wheathampstead(f), to make related alterations of the boundaries of Harpenden South and Wheathampstead wards of the city of St Albans, and Harpenden South West and St Albans Rural electoral divisions of the county of Hertfordshire:

Accordingly, the Electoral Commission, in exercise of the powers conferred by sections $14(\mathbf{g})$ and $23(\mathbf{h})$ of the 1997 Act, make the following Order:

Citation and commencement

- **1.**—(1) This Order may be cited as the St Albans (Parish Electoral Arrangements and Electoral Changes) Order 2007.
 - (2) This Order, with the exception of article 3(3), comes into force—
 - (a) for the purpose of proceedings preliminary or relating to any election to be held on the ordinary day of election of councillors in 2007, on the day after that on which it is made;
 - (b) for all other purposes, on the ordinary day of election of councillors in 2007.

- (3) Article 3(3) comes into force—
 - (a) for the purpose of proceedings preliminary or relating to any election to be held on the ordinary day of election of councillors in 2009, on 15th October 2008;
 - (b) for all other purposes, on the ordinary day of election of councillors in 2009.

Interpretation

2. In this Order—

"city" means the city of St Albans;

"county" means the county of Hertfordshire;

"map" means the map marked "Map referred to in the St Albans (Parish Electoral Arrangements and Electoral Changes) Order 2007", of which prints are available for inspection at the principal office of the Electoral Commission;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983(a); and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section $8(\mathbf{b})$ of the Representation of the People Act 1983.

Alteration of the areas of parish and city wards and county electoral divisions

- **3.**—(1) The areas coloured and designated by the letters "A" and "B" on the map shall become part of Harpenden South parish ward of the parish of Harpenden.
- (2) The areas coloured and designated by the letters "A" and "B" on the map shall cease to be part of Wheathampstead $ward(\mathbf{c})$ of the city and shall become part of Harpenden South $ward(\mathbf{d})$ of the city.
- (3) The areas coloured and designated by the letters "A" and "B" on the map shall cease to be part of St Albans Rural electoral division(\mathbf{e}) of the county and shall become part of Harpenden South West electoral division(\mathbf{f}) of the county.
- (4) The area that ceased to be part of the parish of Redbourn and became part of the parish of St Michael in consequence of the St Albans (Parishes) Order $2002(\mathbf{g})$ shall cease to be part of Beaumont parish ward of the parish of Redbourn.

Map

4. St Albans City Council shall make a print of the map available for inspection at its offices by any member of the public at any reasonable time.

Electoral register

5. The registration officer for the city shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to proposals made to the Electoral Commission for changes to electoral arrangements for the parishes of Harpenden, Redbourn, St Michael and Wheathampstead, and for related alterations of the boundaries of Harpenden South and Wheathampstead wards of the city of St Albans, and Harpenden South West and St Albans Rural electoral divisions of the county of Hertfordshire as a result of changes to the boundaries of the parishes of Harpenden and Wheathampstead made by the St Albans (Parishes) Order 2002.

The new electoral arrangements apply in respect of parish and city elections to be held on and after the ordinary day of election of councillors in 2007, and county elections to be held on and after the ordinary day of election of councillors in 2009.

Article 3 alters the boundaries of Harpenden South ward of the parish of Harpenden, and Beaumont ward of the parish of Redbourn, Harpenden South and Wheathampstead wards of the city of St Albans, and Harpenden South West and St Albans Rural electoral divisions of the county of Hertfordshire.

Article 5 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

The map defined in article 2 shows the area transferred to Harpenden South ward of the parish of Harpenden, and between Harpenden South and Wheathampstead wards of the city of St Albans, and Harpenden South West and St Albans Rural electoral divisions of the county of Hertfordshire.
